1.2 The Charity acknowledges that it will not be held responsible for the content, accuracy, or authenticity of the stories shared by the contestants. The contestants shall be solely responsible for their entries and any consequences arising from their participation.

1.3 The contestants participating in the contest will do so voluntarily, and their decision to share their stories is of their own free will.

1.4 The Project shall provide the Charity with the necessary contest guidelines and promotional materials for dissemination.

2. Consent and Privacy

2.1 The Project shall obtain explicit consent from each contestant before publishing their stories on the Project's website and social media platforms.

2.2 The Project shall ensure that all data collected from the contestants, including personal information and stories, will be handled in accordance with applicable data protection laws and regulations.

3. Charity Listing and Acknowledgment

3.1 The Project shall list the Charity on its website, [www.messagestotheking.com](http://www.messagestotheking.com), and provide a link to the Charity's website, ....., to raise awareness about the Charity's cause and ways to support it.

3.2 The Charity agrees to be acknowledged as a participant and partner in the contest on the Project's website and promotional materials.

4. Disclaimer of Liability

4.1 The Project, its author, and any affiliated parties shall not be held liable for any claims, damages, losses, or liabilities arising from the contest, including the content shared by the contestants.

4.2 Each party shall indemnify and hold harmless the other party against any claims, demands, or actions arising from its own breach of this Agreement.

5.2 In case of termination, both parties shall fulfill their commitments and obligations until the date of termination.

6.2 No modification or amendment to this Agreement shall be valid unless in writing and signed by both parties.
